Regular Board Meeting Minutes September 11th, 2023

Opening

The regular monthly meeting of the Circle City Curling Club was called to order at 7:04 PM on Sep 11, 2023 (In person and virtual)

Attendance:

Review and Approval of Minutes:

• Aug. 17, 2023 regular board meeting minutes were unanimously approved

Review of Outstanding Action Items:

- Liquor Liability (Jim Puckering) still TBD
- Determination of who is to be considered a member of the club for liquor license purposes with respect to guest days (Bruce Johnston) – Members of clubs who are USCA members can be considered members for purposes of liquor license regardless of their personal USCA membership status

Treasurer's Report:

- \$4450 in additional donations received
- Oktoberfest Spiel has been cancelled and refunds are being processed
- Utilities for Aug include annual DI costs
- Cabinets and flooring were the main building project expenses in Aug
- \$35,000 remaining in building fund
- Keith Hammer is working on estimate for frame-out of changing area
- Aug financial reports were unanimously approved

Committee Reports:

Facilities Committee Report

- Expansion is taking place in 3 phases:
 - Phase 1: Cave/lobby area very close to complete and usable
 - Phase 2: Special events space All rough-in plumbing and electrical done; framing done; waiting on electrical permit and inspection, to be followed by framing inspection, then drywall can be completed, followed by cabinets. Goal is to have Special Event space ready by end of October
 - O Phase 3: Changing area cannot be started until Phase 1 and 2 are done
- Posts are being set for parking lot lights
- Landlord is to install new door to common area
- Ice installation had encountered a number of setback/delays:
 - Installing strips for Klutch system took more time than expected and delayed flooding
 - Had problems with some of the DI tanks one set was bad and had to be exchanged; delay in receiving new set

- Condensation issue causing dripping onto ice causing "stalagmites" hopefully this issue resolves as weather gets cooler; perhaps humidifier should be run a week or so before ice goes in; perhaps board should consider a later start date in fall next season
- Ice crew is in otherwise good shape; has been expanded and there should be good coverage for league season
- Landlord has reimbursed us \$1500 for plumbing work
- Klutch hardware has only been received for one sheet; remaining 2 sets to be delivered next year

Fundraising Committee Report

- Expansion fundraising campaign has raised approx. \$24,000
- Merchadise store (operated by Lucky Dog Promo) set to open soon
- Sponsorships no activity due to lack of fundraising volunteer availability

Bonspiels Committee

- Oktoberfest Spiel cancelled due to lack of interest
- Patriot Games Spiel 10 teams registered so far
 - Need more exposure either through members sharing with friends at other clubs or through social media
 - Some members have free entries due to Dedicated Ice donations; these people will have first opportunity to put teams in
 - o Action Item: Sharon Martin to ask Keith Graul to post to curling-related pages
 - o Action Item: Keith Hammer to send follow-up emails to clubs

Private Events Committee

- Jim Gangnon working on following up on recent enquiries to get events scheduled
- Biggest challenge for holding private events is availability of volunteer instructors; to help with that an instructor training clinic to be held on Sep 24 or 30

Learn to Curl Committee informational meeting scheduled for Sep 18th

New Member Integration Committee

- 1st meeting to be held next week
- Sharon Martin will coordinate with this committee for new member communications

Communications Committee

- Peggy-Ann Hoy has agreed to do newsletter again this season
- Committee would like to know what the Board's priorities/goals are for this season
 - Consistent communication on club happenings
 - o Communications to support new member integration/retention

Leagues Report:

- Most leagues are full; room in the Sunday afternoon league; Wed night was cancelled
- Registration for Session 2 will be released about 2 weeks after start of Session 1
