Curling Quiz

1. (Easy) True or False? A stone must be clearly released from the hand before it reaches the hog line at the delivery end. If the player fails to do so, the stone is immediately removed from play by the delivering team.

2. (Medium) If a stationary stone, which would have had no effect on the outcome of a moving stone, is displaced, or caused to be displaced by a player. Choose the correct answer below.

A. If the stone belongs to the offending team, it is removed from play.

B. It is replaced, by the non-offending team, to its position prior to the violation taking place.

C. If the stone was not accidentally pushed out of play, it remains at its new position. If pushed out of play, the non-offending team replaces it to its original position.

3. (Hard) Which of the following statements is false pertaining to if a team accidentally delivers two stones in succession in the same end:

A. The second stone is removed and any displaced stones replaced, by the non-offending team, to their positions prior to the violation taking place. The player, who delivered the stone played by mistake, redelivers it as the last stone for the team in that end.

B. If the infraction is not discovered until after the delivery of a subsequent stone, the end is replayed.

C. The second stone is removed and any displaced stones replaced, by the non-offending team, to their positions prior to the violation taking place. The second thrown stone is then removed from play for that end, and the player, on the offending team, that delivers the last two stones, only delivers one stone.
